Agenda Item No.3

Revision of legal fee of SAI empanelled Legal Council at SAI HO

It is submitted that SAI is an Autonomous Body under Ministry of Youth Affairs and Sports, Government of India which was established under Societies Registration Act. Therefore, there is no compulsion to appoint Government Standing Counsels to defend the Court Cases on behalf of SAI. Hence, SAI empanelled the Advocates from Open market. Initially SAI appointed Shri KC Sharma, Senior Advocate and specialist in Service matter, thereafter, Shri Inderjit Singh, Shri S. Mukherjee, Shri Yogender Kumar, Shri M.K Gupta & Shri Anil Grover, Advocate, were empanelled Shri Anil Grover empanelled with SAI in February, 2003, still continues to defend SAI Court matters. The terms and conditions approved in year 2003, placed at **Annexure-I** were revised last in 01.04.2012. Thereafter, three more Legal Counsels were empanelled in year on the same terms & conditions (**Annexure-II**). However, the Panel Advocates are requesting for the enhancement of Legal Fees. Therefore, a Committee was constituted to consider the matter.

The Committee observed that the fee structure of SAI advocates is different from the fee structure of Government Standing Counsel fixed by Ministry of Law and Justice vide its OM dated 01.10.2015 (a copy of the OM dated 01.10.2015 is attached at **Annexure-III**). As per the fee structure of SAI advocates, the fee for the appearance in Court is @ Rs. 2,700/- per day per Case irrespective of status of the Court. Whereas the fee structure for appearances as per the Office Order of Ministry of Law & Justice is different for different Courts. The fee schedule for SAI empanelled advocates is slightly higher in respect of High Court and CAT Cases but is quite lower in respect of Supreme Court Cases. Hence, the Committee observed that the fee structure of Supreme Court Cases of Government Standing Counsels is quite high i.e. Rs. 13,500 per case per day for Group 'A' Counsel Rs. 9,000/- per Case per day for group 'B' & 'C' group as compared to SAI panel advocates which is Rs. 27,00 per day per case.

The Committee recommended to increase the fee rates of Supreme Court Cases particularly for the appearance charges i.e. Rs. 9,000/- per case per day in respect of SAI panel Advocates. However, for the rest the fee structure may remain the same. The comparison chart of the Legal Fees of SAI Panel Advocate and Government Standing Counsels (Fixed by Ministry of Law and Justice, Government of India) is placed at **Annexure-IV**.

Concurrence of Finance Committee is solicited for the above proposal.

Agenda Item No.4

Payment of Special Fee to Shri Maninder Singh, Additional Solicitor General of India (ASG) for attending the crucial case before Hon'ble High Court of Delhi i.e. MYA&S & Ors. V/s South Delhi Municipal Corporation regarding payment of Property Tax in respect of three Stadia of Delhi owned by the Ministry of Youth Affairs and Sports

The five Stadia (Jawaharlal Nehru Stadium Complex, Indira Gandhi Stadium, Dr. Karni Singh Shooting Ranges, Major Dhyan Chand National Stadium & Dr. SPM Swimming pool Complex) were constructed by Government of India for conducting Asian Games' 1982 and after the Games, transferred to Sports Authority of India in 1984 for the purpose of promotion & development of Sports in the country, management, maintenance and utilization. Since then, SAI is the custodian of these stadia and ownership still lies with Ministry of Youth Affairs and Sports (MYA&S), Govt. of India. The following stadia are within the territorial jurisdiction of SDMC:

- (1) Jawaharlal Nehru Stadium Complex
- (2) Indira Gandhi Stadium
- (3) Dr. Karni Singh Shooting Ranges

1. Payment towards property tax was made by Sports Authority of India till these were handed over to CPWD for up gradation / renovation for conducting Commonwealth Games 2010.
2. SAI approached MYA&S and SDMC against the demand of property tax raised by SDMC in the year 2012 stating that SAI is not liable to pay property tax as ownership of these properties lies with the Ministry and SAI is only a custodian.
3. Secretary (Sports), MYA&S convened a meeting on 22.12.2014 during which it was decided that SAI will pay Service Charges @ 33% of property tax on behalf of MYA&S in respect of Stadia falling under the jurisdiction of SDMC till a final rate is arrived by mutual consent.
4. As per the decision, service charges against property tax from 2004-05 to 2013-14 were calculated as Rs. 15,67,44,511/- .
5. As per decision during meeting with Secretary (Sports), MYA&S on 22.12.2014, Service Charges on the property tax amounting to Rs. 4,23,74,824 /- for FY 2014-15 were also paid.
6. A Warrant of Distress was issued by SDMC on 16.03.2015 to Andhra Bank, JN Stadium, asking for attachment of Rs. 20 crore and to pay the amount to the Commissioner, SDMC.
7. After Legal advice, advising not to take any action on warrant issued by SDMC was issued to Andhra Bank with copy of Court Order in WP (C) No. 1830/2015 in the matter of SAI V/s SDMC setting aside Show Cause Notice issued by SDMC and directed the Respondent Corporation to consider the contention of the Petitioner as raised in the Petition and pass Speaking Order within a period of two weeks from 27.02.2015.

- 8 SDMC again issued warrant of distress on 02.09.2015 to bankers of SAI i.e. Canara Bank and Andhra Bank. This time, copy of warrant issued to Canara Bank was not given to SAI and a sum of Rs. 36,53,52,863,43 was remitted by Canara Bank to SDMC on 03.09.2015.
- 9 The remittance made by Canara Bank was against the orders of Supreme Court of India dated 19.11.2009 in Civil Appeal No. 9458-63/2003 – filed by Rajkot Municipal Corporation & others V/s UOI circulated by Ministry of Urban Development, Government of India vide No. N-11025/26/2003-UCD dated 15/17.12.2009.
- 10 In view of the above, it was decided that Writ Petition before the Hon'ble High court by MYA&S and SAI jointly against the warrant of distress issued by SDMC be filed since Stadia belong to Government of India and SAI is merely a custodian. The then Secretary (Sports) ordered to engage Senior Counsel in the matter to place the facts forcefully before the Hon'ble Court.
- 11 The Writ Petition was filed in the fore noon & the Hon'ble Court was requested to hear the matter on the same day as the warrant of distress was in operation. Shri Maninder Singh, Additional Solicitor General was engaged to plead the case on behalf of petitioners. By the extra ordinary efforts made by the SAI Advocate & ASG, SAI succeeded to obtain Stay Order against the Warrant of Distress issued by SDMC. Due to the timely action 100 crore available in SAI account in the Andhra Bank could be saved. The legal fee of Rs. 5 lakh per hearing and Rs. 55,000/- for conference prior to hearing was decided for Shri Maninder Singh for attending this crucial matter, along with the SAI panel Advocate.
- 12 Since the matter was extremely important involving huge financial implications, it was felt essential to continue with Shri Maninder Singh, ASG to attend the subsequent hearings in the matter before the Hon'ble High Court.
- 13 The payment of special legal fee of the tune of 5 lakh per hearing and Rs. 55,000/- for conference prior to hearing to Shri Maninder Singh, ASG is being made to attend this important & crucial matter.

Agenda Item No.5

Tripartite MoU for setting up International Boxing Academy at IG Stadium, Delhi / Rajiv Gandhi Sports Complex at Rohtak(Haryana)

Shri Ajay Singh, President Boxing Federation of India sent a proposal for setting up an International Boxing Academy in India in association with International Boxing Association (AIBA). Accordingly, a tripartite MoU amongst AIBA (International Boxing Association), BFI (Boxing Federation of India) and SAI (Sports Authority of India) to set up an International Boxing Academy at Indira Gandhi Stadium, New Delhi / Rajiv Gandhi Sports Complex at Rohtak,(Haryana) was signed in the forenoon of 1st March 2017(**copy of agreement annexed**).

The motto of the academy will be to provide a single training method, through experienced coaches and with scientific support, which will cater identification and nurturing of young talent at both sub-junior and junior levels. It will also train elite athletes on a run up to their preparations for International competitions. The International Boxing Academy will have satellite academies and eight (8) Regional Centres will be further developed under the Academy.

The terms of MOU will be for 5 years with provision of renewal on mutual agreement. During the term, the three Parties shall be jointly responsible for implementation for the Development of World Class Boxing infrastructure(Boxing Gym & Rings etc.) in India, Development of the Boxers, Coaches and Referee and Judges(RJs) and providing the necessary facilities, Talent identification, Development and training of boxers with focus on Olympics 2020, Asian Games, Youth Olympics and other International Boxing Competitions, Getting foreign experts to the Academy to train the boxers, coaches and RJs, Sending Indian Coaches, RJs abroad to improve their knowledge, Development of coaching framework in India and Development of the academic programs and scientific aspects of training methodologies.

Under the MoU, AIBA will Share its knowhow and knowledge about training methodology talent identification, high level training and development strategy, information related to the management of the International Boxing Academy at a high level, Conduct training courses for coaches in order to develop the grassroots level of boxing in India, Assist in the preparation of a coaching framework for boxing in India, Assist in inviting foreign coaches or send Indian coaches abroad & Send experts/coaches/RJs twice a year for a period of 2 weeks to assist the RJs and coaches in training of boxers.

BFI will select the trainees for the International Boxing Academy in association with SAI Develop a Long Term Development Plan for the International Boxing Academy, Prepare a detailed plan for inviting other National and International boxers to the Academy, & set up an evaluations system to monitor progress of the boxers.

SAI will provide all necessary infrastructures, boarding and lodging facilities to all trainees, sports equipments required at the Academy, necessary office equipment that is required to administer the academy, funds for the salary for coaches, administrative staff and support staff as per the SAI norms.

Concurrence of Finance Committee is solicited for above proposal.

- a) **Parity of Sports Kit expenses of Non-Residential Trainees under STC/SAG and Extension Centre Schemes.**
- b) **Parity of Competition Exposure expenses among Non-Residential trainees of STC/SAG and Extension Centre Schemes.**

1.0 Sports person selected under SAI Training Centre (STC), Special Area Games (SAG) and Army Boys Sports Company (ABSC) Scheme are admitted either on Residential and Non-Residential basis. The trainees selected under Extension centres of STC/SAG scheme are admitted only on Non-Residential basis.

1.1 Sports person admitted under Residential Basis are entitled to a Block Grant of Rs.12,000/- per trainee per annum to meet the expenditure towards Sports Kit (Max. of Rs.5000/-), Competition Exposure, Educational Expenses, Medical and Insurance. The said Block Grant was concurred in the 62nd Finance Committee Meeting held on 20.12.2012 and approved by the Chairman Governing Body on 03.02.2013. From the Block Grant of Rs.12,000/- the Regional Heads were permitted to spend Max. of Rs.5000/- on Sports Kit and the remaining grant of Rs. 7000/- towards Competition Exposure, Educational Expenses, Medical and Insurance with the provision to utilize the savings from one head to other head.

2.0 The sportspersons admitted under STC/SAG schemes on Non-Residential basis are also entitled to financial assistance in the form of Sports Kit of Rs. 4000/- per trainee per annum, Competition Exposure of Rs. 3000/- per trainee per annum, Insurance of Rs. 150/- per trainee per annum and Stipend of Rs. 6000/- per trainee per annum. The sports person admitted under Extension centre of STC/SAG schemes though entitled to same financial norms except Competition Exposure that they get Rs 2000/- per trainee per annum.

2.1 Since, the trainees admitted under Non-Residential basis in STC/SAG and Extension centre of STC/SAG schemes undergo sports training in their respective sports discipline along with residential trainees, therefore it is necessary to extend them the same treatment as far as the financial norms are concerned.

2.2 Therefore, to maintain parity of financial norms among the sports person admitted under Residential and Non-Residential basis in STC/SAG and Extension centres of STC/SAG schemes, the following is proposed:

3.0 To bring uniformity and parity of amount payable towards Competition Exposure among the Non-Residential trainees of STC/SAG schemes and Extension centre of STC/SAG schemes, the existing Competition Exposure of Rs. 2,000/- per trainee per annum under Extension Centre scheme proposed to be enhanced to Rs. 3,000/- per trainee per annum at par with Non-Residential trainees of STC/SAG schemes.

3.1 Within the existing strength of trainees of Extension centre scheme the financial implication on enhancement of Competition Exposure charges bringing at par with Non-Residential trainees of STC/SAG schemes would be approximately of **Rs.0.16 Cr.** during 2017-18.

Replacement of Synthetic Hockey Turf No. 2 at SAI CRC Bhopal at an estimated cost of Rs. 468.00 lakh

Background and Justification

SAI Central Regional Centre, Bhopal is one of the most preferred venues for holding National Camps for Hockey owing to the boarding, scientific support and rehabilitation facilities.

Presently there are two Hockey Synthetic Surfaces at Bhopal. One main surface has been replaced prior to RIO Olympic 2016. The 2nd Synthetic Hockey Surface has outlived its life and warranty is also over more than three years back.

At present regular camps are conducted at Bhopal Centre, however, due to slippery condition of the 2nd Synthetic Hockey Turf and below par state of the turf, it is not being used. It is thus imperative that the existing Hockey Surface be replaced with the latest specified surface as approved by FIH.

Design & Scope

1. Taking out old Synthetic Hockey Turf
2. Providing & Laying of FIH Global Category Hockey Synthetic Turf
3. Providing & Laying of Dense Graded Bituminous Macadam
4. Providing & Supplying Tack coat on existing Bituminous Surface
5. Misc Repair / Renovation of allied facilities

Financial Implication

The preliminary cost for the replacement of one turf is Rs. 360.00 lakh (based on estimates prepared in March'2014) after adding 30% escalation during the intervening period amounting to Rs. 108.00 lakh { @ (10 % p.a. for 3 years i.e. from March'2014 to March'2017) } on the estimate approved for the main Synthetic Hockey Turf at Bhopal, the total financial implication is Rs. 468.00 lakh (**annexed as Annexure**).

Justification and background

The hall multipurpose hall had been constructed in the year 1988-89. The MP hall is used for training of sports disciplines like Boxing, Judo, Taekwondo, Sepaktakraw, Weightlifting etc.

A team of construction agency headed by Executive Engineer along with JE SAI had visited on 27.01.2017 at SAI SAG Aizwal to inspect the existing infrastructure. In the report, it has mentioned that major portion of the MP Hall has been damaged with the failure of the retaining wall. The entire roof sheet has deteriorated and heavily leaking during monsoon, thereby effecting day to day training of sports persons. The existing toilet facility is also inadequate. Hence renovation and up-gradation of MP Hall is considered essential.

Scope of work

1. P/F 40 mm thick paneled doors & dismantling the same
2. P/F of doors hardware's
3. Replacement of broken glass panels in the window shutters
4. Construction of new toilet blocks
5. Floor tiling
6. Plastering Brick work & CC flooring for Line drains & Plinth protection construction.
7. Pre-coated profile sheet roofing.
8. Painting.
9. Lighting system.

Financial Implication

The football ground of this centre is very hard and covered with wild grass and not in a playable condition. In order to meet the requirements of a proper football field in this centre with a view of training for Indian Teams and revenue generation through ISL, hiring out for various tournaments, summer Coaching Camp, Come and Play Scheme etc., the existing turf need to be laid with natural grass with sprinkler system, drainage, fencing, change rooms, store rooms and 300 lux flood lighting and other allied facilities as per FIFA standards for training round.

Financial Implication

The Estimated cost for the above project is Rs. 211.20 lakhs (**Details annexed as annexure**).

Up-Gradation of two Electrical Sub stations, installation of stand by generators and allied works at SAI NSSC Bengalurua at an estimated cost of Rs. 370.00 lakh

Justification and background

There are two Electrical Sub Stations of 250 KVA and 150 KVA each for the residential sector and Playfield sector respectively which were commissioned in the 1990. During the past 27 years, lot of degradation has taken place for the transformer and distribution system. The specifications and safety requirements have also undergone tremendous changes. The connected load and power requirement has considerably increased due to commissioning of new installations like Shooting range, two nos. of Hockey turfs with flood lighting, two nos. of 100 Bed Hostels for National Campers with Air conditioners, modern scientific, conditioning and rehabilitation equipments which required additional power. The existing transformers are required to be replaced, two Nos of 500 KVA generators are to be installed with automatic change over system and also to have direct power for flood lighting systems of Hockey, Football, Athletics (proposed) and Indoor Halls.

The sub stations need to be upgraded with spun poles, HT and LT cable are to be replaced, automatic power control and change over systems are required to be installed.

The work is essentially to be done immediately to meet the safety norms of the Electricity Board failing which the power supply may be disconnected. A rough cost estimate has been prepared with the help of BESCOM authorities.

Financial Implication

The Tentative estimated cost is Rs. 370.00 lakh(**Details annexed as annexure**).

It is being done to produce quality coaches to popularize sports at grass root levels. Besides regular diploma courses, Institute is conducting Masters' Course in Sports Coaching. Of late Institute is also conducting various skill development courses (**A scheme envisaged by the Ministry of Youth affairs & Sports, Govt. of India**) on regular basis. Institute is already short on providing accommodation to its students, as National Coaching Camps in different Sports disciplines are also held at this Institute under long term development programs. Separate hostels are earmarked for National Campers herein, thus diploma students are not accommodated.

Keeping in view the increased intake of regular diploma students and also to run skill development courses under various disciplines simultaneously at this institute, need is felt to create and construct a new 150 bedded hostel.

It is also submitted that all the estimates by any PWO/PSU are prepared as per CPWD Manual, Plinth Area Rate and CPWD Delhi Schedule of Rates,

It is further submitted that as per procedure the PWO will further call tender by competitive bidding for the work as per CVC/GFR guidelines and subsequently award the contract to the lowest quoting bidder. The payments will be released / paid as per the actual cost of work.

As such these estimates are approximate and the actual cost of work may change after the contract is awarded based on competitive bidding process as per CVC/GFR guidelines.

As a result of which, the present condition of the synthetic surface found deteriorated due to wear and tear causing difficulties for the trainees to continue their training programme smoothly on this surface. Keeping this in view, it is proposed to replace the existing Synthetic Athletic Track with the new blue surface along-with other allied faculties. The rough estimated cost for the same comes out to Rs. 610.00 lakh.

Design & Scope

1. Dismantling of existing worn out Synthetic Athletics Surface.
2. Up-gradation of existing flood light system surrounding the ground.
3. C/o of toilets and bathrooms (Gents & Ladies) beside the athletic ground.
4. Providing an installation of new synthetic athletic track.
5. Repairing of old base course over which the new synthetic athletic track will be laid.

Construction of Vertical extension of Sports Science Centre at LNCPE, Trivandrum at an estimated cost of Rs. 145.95 lakh

Background and Justification

The Lakshmi Bai National College of Physical Education (LNCPE) Thiruvananthapuram is the only Institution under Sports Authority of India established with the objective of producing quality Physical education teachers and for conduct of research in the field of Sports Sciences. The College was inaugurated on 17th August 1985 purely as College offering under graduate / post graduate courses in Physical Education. Later on SAI Schemes such as STC/COE, National Sprint & Jump/Football academies also started functioning from the campus. Over the years this Institution has also earned the reputation being the much sought after venue for conducting various State and National level coaching camps.

SAI, LNCPE has developed multi dimensionally with the introduction of various new courses and schemes. The new courses commenced are M Phil, diploma in Sports Coaching and other periodic refresher courses. The addition of Football Academy, Athletics & Sprint Academy necessitated the need for extra classrooms and counseling hall. The National campers also require classrooms for interaction with experts every often. In order to meet the additional demand for classrooms, an estimate has been prepared to modify the existing Sports Science Centre by extending vertically, so that five additional classrooms can be created economically.

SAI, LNCPE is having a fully fledged International Standard Synthetic Track. But toilets, change rooms and other standard facilities required for the athletes are not attached to the stadium. Besides STC trainees and Physical Education students at the Stadium is being utilized by National Campers, Jumps & Sprint Academy trainees, Elite athletes of various other schemes, Centre of excellence trainees etc. Regularly, Very Often the stadium also utilized for various district level and state level competitions. Due to the absence of a facility centre the athletes practicing in the track are finding it difficult to meet their basic needs.

Design & Scope

1. C/o facility Centre comprising toilets and bathrooms.
2. C/o of change Rooms
3. C/o of Medical Room
4. C/o Canteen and Store room
5. Misc. Renovation of allied facility

Financial Implication

The estimates are awaited. However, the rough estimated cost of the work is Rs. 300.00 lakh.

As such these estimates are approximate and the actual cost of work may change after the contract is awarded based on competitive bidding process as per CVC/GFR guidelines.

Supply and Laying of Synthetic Athletic Track 400 M (8 Lane) at SAI STC, Banaras Hindu University, Varanasi (UP) at an estimated cost of Rs. 754.00 lakh

Background and Justification

SAI has established STC in Varanasi in the discipline of Hockey, Athletic, Basketball and Football. The present strength of discipline wise is as under:

1. Hockey	-	23
2. Athletic	-	14
3. Football	-	12
4. Basketball	-	19

The proposal for establishment of STC Girls Wing Banaras Hindu University, Varanasi (UP) was concurred in the 77th Meeting of Finance Committee of Sports Authority of India held on 27th February 2017.

From the above it is seen that large population of Sports person apart from the enrolled training of BHU make use of facilities available in the BHU, Govt. of India has already sanctioned. Hockey Synthetic Surface for BHU for which funds have also been released. However, the work is yet to commence. Construction of Synthetic Athletic Track will be a big boon for whole of the Varanasi as there is no Synthetic Athletic Track is available in surrounding district. With the creation of International level facility the players from the eastern part of UP and the students of physical education enrolled in the University will be benefited in addition to SAI trainees.

Design & Scope

1. Laying of Synthetic Athletic Track in International competition and IAAF approved 400 mtr 8 lane Synthetic including all sub base treatment as per the international norms
2. Construction of drain
3. Providing and fixing of IAAF approved instrument make: VINEX, AFN Sports, Schaper, Polanik etc.
 - a) Discus throw with cage, Pole and net.
 - b) Discus Hammer combined with cage pole and net
 - c) Shot-put
 - d) Pole-vault
 - e) Long Jump take-off Board
 - f) Triple Jump take off Board
 - g) Stop board for shot put
 - h) Water jump Hurdle
 - i) Aluminum kerbing
4. Providing and fixing of G.I Chain link fabric fencing.

The Indian National Teams in Hockey and Athletics is undergoing long term training at this centre and also other National Campers require 'HYPOXIA' training and protocols for which at Hypoxia Chamber has to be constructed on the space available adjacent to the Sports Sciences building or first floor of the Physiology laboratory (to be constructed).

Financial Implication

The estimates are awaited from PWO. However, the rough estimated cost of the work is Rs. 280.00 lakh.

Vertical Extension above the existing Grand Stand Cum Administrative Building and Installation of PVC Chairs at the Gallery of SAI Regional Centre Guwahati at an estimated cost of Rs. 127 lakh

Justification and background

The SAI Regional Centre Guwahati was established in the year 1987 as SAI Sub Centre. Subsequently, in due course of time it is recognized as Regional Centre to look after the overall developments of sports in the state of Assam, Arunachal Pradesh, Meghalaya & Sikkim. It is situated in the heart of the city in congested area of 7.5 acres of land. However, in spite of small area, the Regional Centre has created sports facilities in 9 (nine) disciplines i.e. Athletic, Archer, Badminton, Boxing, Fencing, Football, Taekwondo, Lawn Tennis & weightlifting. The centre has also produced many international reputed sports persons.

Since the Football Ground of SAI, Regional Centre is being upgraded for U-17 WC Football Tournament to be held at Guwahati in the month of Oct, 2017. Sufficient rooms for press, media are required to be created. As there is hardly any space available under the SAI RC Guwahati campus, the required facilities may be created above the Grand Stand by constructing vertically to cater the requirement during conduct of U-17 World Cup Football Tournament. These rooms will also be of good use for the Regional Centre after the game is over, which can be converted into library/audiovisual aid/conference room etc and at-least 1000 capacity of seating arrangement is to be made for spectators at the Gallery. This will have better utilization for U-17 WC and also be able to conduct games like Himalayan Regional Games etc.

Financial Implication

The estimated cost is Rs. 127.00 lakh (**Details annexed as Annexure**).

Construction of Remaining Boundary Wall at SAI STC Kandivali at an estimated cost of Rs. 250 lakh(Phase-II)

Justification and background

The Governing Body of SAI, in its 44th Meeting held on 25th May, 2015 has separated the SAI Centers situated in the State of Maharashtra, Goa and Union Territories of Daman & Diu and Dadra & Nagar Haveli from the jurisdiction of SAI Western Regional Centre at Gandhinagar, Gujarat. Henceforth, the State of Maharashtra, Goa and UTs of Daman & Diu and Dadra and Nagar will function independently under the Regional Director/ Director who is currently based at STC, Kandivali.

The boundary wall is porous at many locations leading to encroachment. The height of the boundary wall also needs to be increased in some stretches for security reasons.

The total estimated cost of Rs. 350 lakhs for complete Boundary wall was submitted by the RC Kandivali however but due to fund constraint in 1st Phase only essential work of boundary wall was taken up for Rs. 100 lakhs which was approved by 45th GB dt. 10.7.2015. The work is now nearing completion.

Now the balance work of boundary wall is required in Phase-II.

Financial Implication

The estimated cost of balance boundary wall is Rs. 250 lakhs (**Details annexed as annexure**).
